### **Requirements and Eligibility**

- A talented, young musician studying cello in his or her sophomore, junior or senior year of high school.
- A United States citizen and a legal resident of Michigan.
- Applicant must be majoring in music performance or a music-related field, such as music education, composition, conducting, etc.
- An application fee of \$25.00 is required. Please make your check out to Psarianos Violins Ltd. and enclose it with your audition application.

### **Performance Rules**

- Each contestant must perform two memorized, contrasting movements of a solo Bach Suite.
- Each contestant must perform one memorized movement of a standard concerto. The choice of the concerto is left to the discretion of the contestant. The concerto should be selected to demonstrate virtuosity as well as tone.
- The entire performance time of each contestant should not exceed 15 minutes and be a minimum of 8 minutes.
- **An accompanist is highly encouraged however it is not a requirement.**
