# MSBOA Liaison - Orchestral Activities Winter 2023 Report

This fall, we had the String Orchestra Reading Session in September and the Mid-Level Clinic in October.

The String Orchestra Reading Sessions were held on Saturday, September 24, 2022. There were two sites for the reading session, the east-side site at Plymouth-Canton Educational Park, hosted by Michael Edwards and coordinated by Samantha Farmer (Novi Schools), and the west-side site at Lowell Middle School, hosted and coordinated by Joe Oprea. Approximately 50 orchestra teachers, student teachers and university music education majors participated in the reading session, reading through approximately 40 new orchestra selections for school orchestras for all levels. The same music was used at both sites.

Thank you to Luck's Music for coordinating the donation of the music for this event from the publishers so the music was given away at the reading session. Many thanks to the event hosts, Michael Edwards and Joe Oprea, and the reading session coordinators, Samantha Farmer and Joe Oprea.

The Fall Mid-Level String Clinic on Saturday, October 8, 2022, at Waterford-Kettering High School, Portage North Middle School & South Haven High School. The clinicians worked with 274 middle school students from 10 schools that were divided into 2 orchestras at each site. Thank you to the hosts, Merlyn Beard, Sean Brennan and Jessica Fiedorowicz for the work to make the Mid-Level Clinics a success. Thank you to our clinicians, Sara Jager, Ji Hyun Kim, Jean Lee, Andrew Pool, Rodney Page, and Maritza Garibay (2022 MSBOA Orchestra Teacher of the Year), for guiding the middle school students in their final preparation and performance. Music selection for next year's Mid-Level String Clinic will take place at the spring String Committee meeting.

As we move forward I would like to encourage more middle school orchestra programs to become involved in the Mid-Level String Clinic. In looking ahead to next year, we are tentatively planning on having four sites for this event, Waterford-Kettering, Portage Central, Forest Hills Eastern and Marquette. I would also like to consider including a performance by student groups such as Lowell Fusion Rock Orchestra, Saline Fiddlers, etc. at each site at approx. \$300-500 per site. I believe this has been done in the past.

On December 10, 2022 MSBOA hosted Band/Orchestra Adjudication training. I am waiting to hear how many new string adjudicators completed the training. Currently we have 175 MSBOA adjudicators that have not signed up for the anti-bias training. If they have not signed up for the training by the end of the 22-23 school year they will be moved to an inactive list until they have taken the training. Please encourage anyone you know that hasn't taken the training to do so.

### Studio Chair January 2023 Report

On May 21st, 2023 we will hold the first ever Michigan ASTACAP (ASTA Certificate Advancement Program) at the Jackson Symphony Orchestra building. The current estimate is around 20 students participating. From polling ASTA members the majority of the students will be violinist and a few bass students. With an average of 4 students per hour we would likely need two exam rooms and two warm-up rooms for a total of 5 hours.

I have matched fees to an ASTACAP that occurred in a different state

#### **Levels & Fees:**

• Foundation, 1, and 2: \$40

• Level 3, 4, and 5: \$52

• Level 6 and 7: \$65

• Level 8, 9, and 10: \$75

### **Duration in minutes:**

• Foundation and 1: 8

• Level 2 and 3: 10

• Level 4 and 5: 15

• Level 6: 17

• Level 7 and 8: 20

• Level 9: 25

• Level 10: 30

A \$10.00 fee per participant (included in the calculation of the application fee) is sent by the state chapter to the ASTA national office.

### Outlined below is an estimated budget to be approved.

With 20 students the average payment would be around \$45 (ASTA mentions 70% of students are between levels 1-5) the incoming amount would be \$900. \$200 would go to the National office and estimated \$500 for judges leaving \$200 for a surplus return to MASTA plus padding. We would need around 14 participants to break even.

Certificates are obtained from the ASTA national office by filling out the State Enrollment Form and mailing the form, along with a check (\$10.00 per exam taker) to the national office. The

certificates are either given or mailed to the participating teachers, following the exam, along with a copy of the Evaluation Form for each of their students.

Application deadline should be set to April 1st to give enough time to organize the final details of the event. Registrations will be sent out in January 2023.

### Why MASTA

The basis for my becoming a strings teacher has never wavered – a fervent credo that the orchestra as a vital part of our culture and therefore, an integral component of the educational system. Being an orchestra teacher wasn't my "plan B"; it was a passion for bringing great orchestral music to as many people as possible – it was a mission.

As a beginning teacher, ASTA was a source of information and inspiration. The ASTA Journal was one of the few places one could find information about the craft of teaching. While ASTA meetings, conferences and workshops were incredibly inspirational – having the opportunity to spend time with like-minded people was incredibly motivational. These activities provided time with some of the great educators to "pick their brains" and see what it takes to be successful.

The internet has changed the information base. While the ASTA Journal is still a great resource, there are wellsprings for knowledge that are available through a simple internet search.

So why should someone join ASTA? The answer is people. I know I'm "speaking to the choir" in most cases, but we need to push our colleagues to become an ASTA member or maintain membership in ASTA. One can never know where inspiration may come from. We all need to participate in activities that brings teachers together to re-focus our energies, re-affirm our commitment and move forward orchestral education.

#### How MASTA

Crucial to my development as a teacher was my attendance in the 1980s at the National String Workshop in Madison, Wisconsin which does not exist anymore. This workshop brought

together members of major orchestras, professors from universities throughout the country, teachers from all corners of the country and university students for a week-long, 10-hour day of instruction and activities. In addition, we all stayed on the same campus so opportunities to mingle with some of the greatest orchestral minds was easy. Dr. Hopkins' workshop at the U of M and Dr. Gillespie's workshop at OSU are the closest examples of present-day programs.

My goal is to provide another opportunity for collaboration and association through our MASTA "retreat" for us to come together and re-charge our vision and inspiration.

For this year, I am proposing we a one-day retreat on the last Friday of our MASTA String Camps – June 30 - at the Howell Nature Center. We will make some music, talk pedagogy and "hang out". Information will be forthcoming.

### MASTA 2022 Elizabeth E. H. Green Solo Competition

### Winter 2023 Report

The 21st biennial MASTA Elizabeth E. H. Green Solo Competition Final Round was held on November 13, 2022 at Hillsdale College in Hillsdale, Michigan. Guest competition judges were two principal members of the Toledo Symphony: Kirk Toth, Concertmaster and Amy Chang, Associate Principal Cello. Collaborative pianists were Thomas Ryskamp and Taylor Flowers.

The First Place, Gold Medal and \$1,000 prize money was shared by two violinists: Javier Torres Delgado (Danielle Belen, teacher) for his performance of the Concerto for Violin in G Minor, Op. 80, movt. 1 by Samuel Coleridge-Taylor and Stefan Hubenov (Dmitri Berlinsky, teacher) for his performance of Sonata No. 3 in D Minor: Ballade, Op. 27 by Eugene Ysaye.

The Second Place, Silver Medal and \$500 prize money was awarded to Diego Mieres (Yizhak Schotten, teacher) for his performance of the Rebecca Clarke Sonata for Viola, movt. 1.

Minji Kim's performance of the Prokofiev Violin Concerto No. 2 in G Minor, Op. 63. movt. 1, earned a special Honorable Mention certificate. Sixteen-year old Minji is a student of Aaron Berofsky.

Seven applicants were chosen to compete in the Final Round, selected from a highly competitive First Round of online submissions. Those final round participants were (in addition to those mentioned above): Katelynn Ehlert, harp (Chen-Yu Huang, teacher); Guanqun Li, violin (Junqi Tang, teacher); Cara Wunder, violin (Danielle Belen, teacher).

### Final 2022 Budget

Participant numbers at the 2022 MASTA Solo Competition improved from 2020: 19 students attended the 2022 festival (approx. 42% increase).
